

CONTEST RULES (LONG)

OFFICIAL CONTEST RULES. 1. **No purchase is necessary.** 2. Eligibility for Contest: All Archer Cooperative Credit Union ("Credit Union") members in good standing who comment on the Husker Volleyball Giveaway Facebook post and manual entrants as provided herein; who are 18 years or older and a U.S. resident during the promotion period will be automatically entered as provided below. By submitting any entry, you agree to be bound by these Official Rules. The Contest period begins on March 23, 2023 and ends on April 6, 2023 and applies to entries actually received by the Credit Union during this period. Employees of the Credit Union and their immediate family members residing in a single household are not eligible. All winners will be notified by the Credit Union. If any prize is unclaimed, an alternate winner will be chosen. 3. Prizes. The Credit Union will award a total of Three (3) prizes consisting of the following: a set of two (2) Husker Volleyball tickets to the Husker Volleyball 2023 Spring Match on April 29. 4. Automatic entry and eligibility for this prize contest is based upon: one comment on the Husker Volleyball Giveaway Facebook post during the promotion period. All other entries will be entered in the drawing to win this prize upon receipt of a written entry on a 3 x 5 piece of paper setting forth the member's name, address, telephone number, and account number. One entry per envelope for entries that are not automatic; no photocopied or mechanically reproduced entries accepted; and the Credit Union is not responsible for lost, late, misdelivered, incomplete or postage-due entries. Automatic entrants will be "rolled over" from the initial drawing described under Item 8 herein for each subsequent drawing. Other entries will not be "rolled over," and will only be eligible for the drawing held immediately following receipt of such entries. Entry will be based on the first party named on the account in question regardless whether the account is a multiple party account; and regardless whether the transactions qualifying for this contest are actually conducted by said member.
