

CONTEST RULES (LONG)

OFFICIAL CONTEST RULES. 1. **No purchase is necessary.** 2. Eligibility for Contest: All Archer Cooperative Credit Union ("Credit Union") members in good standing who close a consumer loan with Archer Cooperative Credit Union and manual entrants as provided herein; who are 18 years or older and a U.S. resident during the promotion period will be automatically entered as provided below. By submitting any entry, you agree to be bound by these Official Rules. The Contest period begins on February 1, 2021 and ends on April 30, 2021 and applies to entries actually received by the Credit Union during this period. Employees of the Credit Union and their immediate family members residing in a single household are not eligible. All winners will be notified by the Credit Union. If any prize is unclaimed, an alternate winner will be chosen. 3. Prizes. The Credit Union will award a total of Three (3) prizes consisting of the following: Vizio 65" Class V-Series LED 4K UHD SmartCast TV valued at \$469.99, Vizio 58" Class V-Series LED 4K UHD SmartCast TV valued at \$399.99, and Vizio 43" Class V-Series LED 4K UHD SmartCast TV valued at \$279.99. 4. Automatic entry and eligibility for this prize contest is based upon: one consumer loan closed during the promotion period. All other entries will be entered in the drawing to win this prize upon receipt of a written entry on a 3 x 5 piece of paper setting forth the member's name, address, telephone number, and account number. One entry per envelope for entries that are not automatic; no photocopied or mechanically reproduced entries accepted; and the Credit Union is not responsible for lost, late, misdelivered, incomplete or postage-due entries. Automatic entrants will be "rolled over" from the initial drawing described under Item 8 herein for each subsequent drawing. Other entries will not be "rolled over," and will only be eligible for the drawing held immediately following receipt of such entries. Entry will be based on the first party named on the account in question regardless whether the account is a multiple party account; and regardless whether the transactions qualifying for this contest are actually conducted by said member. To claim the prize, all winners must sign and return a release and an affidavit of eligibility and publicity release to the Credit Union at 510 G Street PO Box 284 Central City NE 68826, within 14 days of notification, or prizes will, in the Credit Union's discretion, be forfeited. The prize will be awarded only if entrants comply with these Official Rules. No cash or other consideration will be paid and winners are responsible for any applicable taxes or other expenses related to any prize awarded. 5. Void where prohibited by law. All federal, state and local laws and regulations apply. 6. By accepting a prize, a winner consents to the use of his/her name and photograph or likeness for advertising and promotional services without additional compensation. 7. Release of Claims: All winners, members of any winner's household, relatives and persons who use any prize awarded by Archer Cooperative Credit Union, and such person's heirs, assigns, executors, and administrators release and exempt Archer Cooperative Credit Union and its directors, officers, employees and agents from any and all claims, actions, demands, chooses in action and damages which they have now or any time in the future arising from use of any prize, including personal injury or death. 8. The name of the prize-winner will be posted at all Credit Union branches and will be published in the Credit Union's other information resources (including the Credit Union's website). Winners will be selected in a random drawing from among the eligible entrants received on or before April 30, 2021. The selection of a prize-winner hereunder will be final.
